**Parts and Service-** Parts and service invoices are payable 30 days following invoice date.
- 2) I understand and agree that the service charge as set out on Stoney Creek Equipment Rentals invoices at a rate of 2% per month (24% per annum) will be applied to all past due purchases calculated from the invoice date on which they become past due. I understand and agree that this service charge may be revised from time to time.
- 3) I understand and agree that my charge account privileges may be cancelled at any time at the discretion of Stoney Creek Equipment Rentals.
